RULES & GUIDELINES

SPORTSMAN MODIFIED QUALIFYING:

Drivers draw for heat starting position at tech inspection on Sunday. Base field 28 starters, provisional starters added if necessary. Winners of "automatic qualifier" races at prior events must make full attempt to qualify. Drivers who are Devil's Bowl Speedway 100% season participants will be eligible to race for up to two (2) provisional positions.

SPORTSMAN MODIFIED DIVISION:

Sportsman Modifieds must follow DIRTcar/Devil's Bowl Speedway rules, with the following addendums:

1. Any driver allowed, regardless of experience.
2. Any part of any car may be impounded for inspection purposes.
3. Minimum weight 2,400 lbs. after race, driver in seat, race-ready.
4. Must use sealed GM "602" crate engine. No "open" engines.
5. Unsealed crate engines must add 200 lbs.
6. Maximum Octane 98 fuel.
7. Must use DIRTcar/DBS-approved rev limiter—6,200 rpm max.
8. Hoosier tires only, minimum D300 compound.
9. Must use MYLAPS transponder.
10. Must use RACEceiver-type one-way radio. No two-way radios.

OTHER DIVISIONS:

King of Dirt Racing Series Pro Stocks will follow all KOD rules and race procedures. Super Stock, Mini Stock, and 500cc Mini Sprint divisions will follow all Devil's Bowl Speedway rules and race procedures.
